# RULES & REGULATIONS

A detailed list of campground rules and regulations can be found on the website, in your site confirmation email upon booking, or in person upon request.

This is a family-oriented park and we look forward to everyone having a great time. We want all of our guests to enjoy our facilities and have a safe, relaxing stay. This will only be possible with your help. Please respect other campers in our park facilities. We reserve the right to protect the rights of our guests, our trees, and other natural beauties for the benefit and safety of all.

**CHECK-OUT TIME:** 11:00 AM.

**PARENTS** are responsible for their children during their stay at the campground. Please do not leave children unattended at any time.

**CAMPFIRES** are part of the camping experience; however, please put them out properly when not attended. All fires must be of reasonable size so as not to endanger anyone or anything. **NO OUTSIDE FIREWOOD IS TO BE BROUGHT INTO THE PARK.**

**PETS:** Are allowed in Camp-Resort. That are to be leashed at all times, and are not to be chained at your site unattended. Pet owner is responsible for cleaning up after the pet and keeping your pet under control. Please inquire about breed restrictions. Non-aggressive dogs only.

**ALCOHOL:** The use of alcoholic beverages must be in moderation and confined to the camper's site or cabin. No public consumption allowed.

**FIREWORKS:** No fireworks of any kind are permitted in the park.

**LITTER:** Please help us keep our park beautiful. Please do not litter.

**QUIET HOURS:** For the comfort of your neighbors quiet time is between 10:00 PM to 8:00 AM. Your children are to be at your site during this time. Noise synonymous with camping is understood, excessive noise is not.

**EXCESSIVE NOISE:** Radios, engines, and any other excessive noises are not tolerated. Please respect your neighbor.

**SAFE, SLOW DRIVING:** Vehicles, bicycles, and golf carts must observe the 5-mile-per-hour speed limit on all Park roads.

**UNLICENSED MOTORIZED VEHICLES:** We do not recommend use motorized scooters, mini bikes due to the mountainous terrain. Campers are not permitted to drive ATVs within the camp resort. ATV usage is permitted only to management, for operational purposes.

**GOLF CART DRIVERS:** Must be licensed drivers. If a licensed adult 21 years or older is in the front seat, a younger non-licensed driver may drive, as long as the adult is active in driving and supervising the non-licensed driver. Golf carts are to be driven on gravel roads within the Camp. No driving on grass. Driving privileges can be revoked at any time at manager's discretion.

**GOLF CARTS:** Any golf carts brought into the park must adhere to the park rules and manufacture's stipulations for usage.

**FISHING:** Fishing is available to all campers; please be respectful of other camper's sites when determining your fishing spot. Fishing after hours is permitted as long as quiet hour requirements are fulfilled.

**THROWING OF ROCKS AND VANDALISM** are not permitted. Any vandalism or throwing of rocks is cause for ejection from the camp-resort.

**MANAGEMENT** reserves the right to evict, at our discretion and without refund, any person whose conduct is objectionable or violates park rules.
