Speed Limit – 5 mph is the speed limit. Exceeding the speed limit may result in being removed from the Park.

Check In/Out – Check-In is 3pm. Cabin rental Check-Out is 11am & Campsite Check-Out is 12pm.

Refunds – There will be no refunds due to the discomforts of Mother Nature or risk to public safety.

Registered Campers – All campers must be at least 19 years of age to rent a campsite & 21 years of age for rental unit. Sites are defined by 1 camper, 1 car, 2 adults and up to 4 children. Additional guests must register at Ranger Station.

Guests/Visitors – Must register at Ranger Station and are required to pay an entrance fee. Car passes must be displayed in the vehicle windshield during your entire stay.

Pets – Must be on a leash and attended to all times and picked up after doing their business. Pets are not allowed in Ranger Station or Comfort Station, Pavilion or in the rental units. If a pet is brought to the Park and you are in rental unit, you will be charged a mandatory pet clean up fee. Due to insurance, no pitbull breeds are allowed in the park.

Quiet Time – Music and talking must be kept to a minimum during the hours of 11pm - 7:00am.

Children – They are not allowed off their campsite without an adult after 11pm.

Bicycles – Must remain at your campsite after dusk. Bicycles should not be ridden up or down the valley hill and the dam.

Motorized Toys - The use of battery operated scooters, go-karts, motorbikes, skateboards, hovercrafts are prohibited within the Park

Swimming – There is no Lifeguard on duty and swim at your own risk. Children under 13 require parental supervision. No pets are allowed in or around the pool. No kiddie or baby pools are allowed in the Park.

Golf Carts – Must be driven by a licensed driver. The cart must have working headlights when driving at night. Proof of insurance and valid driver license is required. Please stay off the grass and away from Recreation Center & Field.

Alcohol – Should remain at your campsite or you must conceal your drink, with a "Koozie or Dixie cup". No open containers are allowed on pool deck, Recreation Center, Ranger or Comfort Station.

Drugs & Underage Drinking – The illegal use of drugs or underage drinking is prohibited within the Park. Local authorities may be contacted without prior notice.

Hazards – Firearms, weapons, explosives and fireworks are not permitted in the Park.

Firewood – No outside Henry or Hancock County wood is allowed. Foraging for firewood is prohibited.

Trash – Please place all trash into the receptacles or dumpsters and remove trash from the rental units when you depart. It is illegal placing and burning trash in the fire rings. Trash left in the rental unit or campsite will be assessed a \$50 clean-up fee.
