

JELLYSTONE PARK PIERCETON PARK RULES

1. All guests must register at the Ranger Station prior to entering the park. For Property Owners, you may add guests to your lot at the Ranger Station by filling out a Guest List card. Guests may then check in at the Registration Office for entry into the park. Violators can be considered trespassing and subject to further action.
2. The Park requires that at least one person in a rental party be 21 years of age. Anyone under 18 years of age must have a responsible parent or legal guardian over 21 years old in the Park at all times. Anyone under the age of 18 shall be on a lot with adult supervision at 11:00pm or ½ hour after the last scheduled activity has ended.
3. Please be considerate of other campers. Noise has no boundaries. Quiet time in the park is from 10:00pm to 8:00am Sunday-Thursday. On Friday, Saturday, and Holiday Weekend Sundays, quiet time is from Midnight to 8:00am. Foul, loud, and/or obnoxious language or any behavior of this type shall not be allowed. If security is alerted to your lot, or to anyone in the park associated with your lot, you will be issued a warning. Subsequent calls on the same night will result in a citation.
4. Alcoholic beverages should be kept on your lot.
 - ❖ **Illegal drugs are prohibited in the park**
 - ❖ **Exposed or openly carrying of firearms is prohibited in the park.**
 - ❖ **Exposed or openly carrying of weapons is prohibited in the park.**
 - ❖ **Projectile devices are prohibited in the park. (this includes Airsoft, Orbeez, BB guns, bows, slingshots, and similar devices.)**
5. Weekend or short term campers are not allowed to bring in a golf cart for use unless a handicapped accessible golf cart is required for their personal use. Golf carts are available for rent through the Park's leased Golf Cart business.

In order to operate a golf cart in the Park, lot owners shall obtain a golf cart permit annually through the Business Office. Current proof of insurance for the cart must be shown, and a \$10 fee must be paid, to obtain a permit. The permit is valid for one season. This permit will be displayed on the cart steering column. Additionally, all golf carts must display 2-inch or larger numbers on the front and rear of the golf cart that match the Lot number the cart's owner. Golf carts must have operational headlights and tail lights and must be turned on from dusk to dawn. Golf carts must be operated in a safe manner obeying all traffic signs. Reckless or hazardous operation of a vehicle in the park may result in a citation.

6. No one under the age of 14 may operate a golf cart unless they are with an adult who is also sitting in the front seat. A special park ID may be issued to someone over the age of 14 allowing them to operate a golf cart within the park. This ID must be carried with the driver whenever they are operating a golf cart within the park. This ID can be revoked for any violation of safe operation.
7. Skateboards, roller blades, hoverboards, 2-wheeled scooters, and any vehicle under 20" in height are prohibited.
8. Pets must be attended to at all times and kept under control by a responsible person. Dogs must be leashed while walking through the park. Pets other than service animals are not permitted in any buildings, playgrounds, or the beach. All dogs must be fully vaccinated. All animal droppings must be disposed of by the owner of the animal immediately. Pets cannot be leashed to park property, including electrical pedestals or water connections. Exotic, vicious, aggressive, or dangerous pets are not permitted in the park.
9. Swimming pool use is restricted to Property Owners, their guests, and renters. Swim at your own risk. There are no lifeguards on duty. Proper swimming attire must be worn at all times. No loud, obnoxious behavior or rough play is permitted. No diving or running is permitted in the pool area. No glass containers are permitted in the pool area. No children with diapers are allowed in the pool, unless the diaper is swim-safe. Inflatable pool toys are to be kept at a minimum size so as not to interfere with other pool users. In the case of an emergency in the pool area, there is an emergency red phone located in the pool area. Use any means necessary to alert the Ranger Station to a pool emergency.
10. Garbage must be disposed of properly. Garbage is to be disposed of in available dumpsters allocated throughout the park. Do not put lawn waste, branches, appliances, mattresses, flammables, or other unauthorized items in the dumpsters. Contact the Ranger Station for these items to be disposed of appropriately in the Pit area. There may be a fee for these items. If you hire a contractor for work on your lot, the contractor is responsible for proper off-site disposal. Dumpsters brought in for contractual work may be placed in accordance to the A&E guidelines and will require approval.
11. **DO NOT DISPOSE OF GREASE, CLOTH WIPES, PAPER TOWELS, DIAPERS, OR FEMININE PRODUCTS THROUGH TOILETS OR SINKS. THESE ITEMS DAMAGE OUR SEWER SYSTEM!**
12. Illegal fireworks, aerial-exploding fireworks, and Chinese candle lanterns are prohibited.
13. Fires shall be contained within a fire ring and monitored at all times.
14. Violations of these rules are subject to citations and/or fines. Multiple violations can be subject to progressive fines.
 - 1st offense – \$25 fine
 - 2nd offense - \$50 fine
 - 3rd offense - \$100 fine
