Guide to Good Camping

This is a family oriented park and we all have a good time. We reserve the right to protect the rights of all our guests, trees, and other natural beauties for the benefit and safety of all.

Speed limit 5 MPH for the safety of all campers. This applies to all vehicles including bikes & electric scooters.

Visitors must register at the Ranger Station. Campers are responsible for their guests.

Parking To preserve the "Camping Spirit," campers are limited to one vehicle per site. Any additional vehicles may be parked in the designated guest parking. This excludes deluxe plus.

Tents/Screened Rooms may be set up in designated tent sites only.

Outdoor Carpets may be used if they are 3 foot by 5 foot or smaller.

Pets are to be on a leash, not left unattended, quiet at all times, out of restrooms, in you camper at night and please clean up after them. Pets are not allowed in rental units or on rental unit sites.

Parents are responsible for their children's actions. Children are to be accompanied to restrooms and pool. They are to be at your campsite during quiet hours.

Campfires are permitted in 12 inches off the ground contained fireplaces. There are fire rings around the perimeter of the park for your use. Always use with safety in mind. Campfire rings are provided at cottages, deluxe, deluxe plus and premium sites.

WiFi is offered free to registered campers. It is accessed at Frankenmuth Jellystone Park. Speed is limited so gaming and large files are not accessible. You must accept terms and conditions to access the internet. If popups are blocked on your device it will not work.

Garbage Place garbage bags directly into dumpsters.

There must be an adult 21 years old or older on your campsite. Children are not to be alone.

Bikes & Rollerblades/Skateboards can be used during daylight hours.

Electric Cars are NOT allowed to charge at campsite. A charging station is available in the mini golf/guest parking lot. Golf Carts are NOT permitted.

Times to Note:

Check Out: Campsites-1 pm. A \$5.00 per hour charge for late check out. Please confirm with camp store prior to 10 am. Based on availability. Rental units-11 am. Sorry no late check out in rental units.

Quiet Hours: 10 pm to 8 am. Please respect your neighbors.

Pool Hours: Vary depending on season. Stop in to the camp store for a weekly schedule.

Church Schedules: Can be found in the camp store.
