Campground Guidelines

- 🐾 **Check-Out Times: Campsite:** 12:00 Noon **Lodging:** 11:00 AM
- 🐾 **Late Check-Outs:** You must vacate your campsite or lodging unit at the above Check-Out Times. You can purchase a Day-Use Pass for \$25/ reservation and stay until 10:00 PM.
- 🐾 **Site Occupancy:** One (1) RV or Tent is allowed per campsite. All RV & Tent sites allow for a maximum of six (6) persons per site.
- 🐾 **Bicycle helmets** are required for ALL children 14 and under (per NYS Law) Helmets are available to borrow from the office with a \$5 deposit
- 🐾 **Golf Carts** may be operated by licensed drivers only. Maximum capacity is 5; all passengers must be seated; absolutely no riding on bumpers, tailgates or windshields.
- 🐾 **Equipment Rentals:** Golf Cart, Paddle and John Boat rentals are available on a 1st come 1st served basis. We encourage you to reserve a Golf Cart prior to your arrival to ensure it is available for your visit.
- 🐾 **Water Attractions:** Occasionally, due to weather or other events beyond our control, we have to close the water park facilities. We make every attempt to limit this inconvenience. Facility closures do not entitle you to a refund for either day use or overnight visitors. During these closures, please use our other facilities.
- 🐾 **Sewer Connections** require a tight seal by a Sewer Donut (or Sewer Ring) or a screw-type connection.
- 🐾 **Ground Disposal** of any drain water (gray or black) is prohibited by State Law. Wastewater from RVs (including sink water) must be disposed of into sewer drains.
- 🐾 **Never Swim Alone.** A minimum of two adults 18 years of age or older must be present whenever this swimming facility is in use, with at least one adult on the pool deck or beachfront. **There is no substitute for adequate supervision.** Children under 16 years of age must be accompanied to the bathing facility by a parent or guardian, or similar adult responsible for their safety and behavior.
- 🐾 **Adult Supervision:** All children under the age of 14 must be directly supervised by an adult (18 years or older) while on Jellystone Park™ property. Any child under 12 requires adult supervision around any of the swimming areas.
- 🐾 **Fireworks & Firearms** are prohibited on Jellystone Park™ property. Includes BB, Airsoft and pellet guns.
- 🐾 **Quiet Time** is 10:00 PM to 8:00 AM. Loud or offensive noises or ill-mannered conduct will not be tolerated at any time.
- 🐾 **Smoking is not allowed** in any Jellystone Park™ buildings, pool or playground areas.
- 🐾 **Speed Limit** is 5½ MPH. Please observe our speed limit to

ensure the safety of all our guests.

- 🐾 **Boat Rentals** only available from 10:00 AM to 6:00 PM.
- 🐾 **Day Use:** During our high season (Memorial Day thru Labor Day), we do not allow Day-Use guests on Saturdays or Holiday weekends. Please call for all the details.
- 🐾 **Visitors:** Your visitors are always welcome at Jellystone Park™, as long as they register at our Ranger Station. Registered guests and their visitors are expected to read and adhere to all Campground Guidelines. All your visitors must register, pay Day-Use Fees, if applicable, and leave resort by 10:00 PM.
- 🐾 **Pets** are welcome but must be kept on leashes or inside at all times and must not be left unattended. Due to health codes, pets are not allowed in or near any buildings, bathrooms, pool or playground areas. They cannot be left outside and must be in your RV. They must always be on a leash and walked by a responsible person to pick up after them immediately.
- 🐾 On behalf of each person in my party, I grant Jellystone Park™ and its affiliated entities and promotional partners the right to include any photographic, video, and other visual portrayals of each person in my party in any medium and for any purpose.

By entering the premises described in the attached Site Map ("Premises"), I hereby consent and authorize Yogi Bear's Jellystone Park™ Camp-Resort in [location] ("Camp-Resort") and anyone else it may authorize, to film, tape, photograph, or otherwise record me and to use the photographs and/or motion pictures and video taken of me, including my name, likeness and voice, as well as any testimonial statements made by myself, and all other aspects of my personality ("Publicity Items"), and any reproduction of them in any form, for the purpose of publicizing, promoting and advertising Camp-Resort's activities in any media now known or later developed, in perpetuity and throughout the world, without further compensation to me.

I further agree to release and hold harmless Camp-Resort, its representatives, affiliates, subsidiaries, agents, officers, directors, employees, successors and assigns, from any and all claims, demands, losses, costs, expenses or damages, including without limitation reasonable attorney's fees, which may arise out of or in connection with any claim by me or alleged to be on my behalf resulting from the use of the Publicity Items, the use of which I now knowingly and voluntarily grant to Camp-Resort, and the full ownership rights of which I now knowingly and voluntarily grant and assign to Camp-Resort.

Further, I acknowledge and agree that I assume all risks and dangers incidental to the activity of camping in a rustic outdoors environment located on the Premises including, without limitation, the danger of being injured by insects or other animals, of being injured while participating in recreational activities, such as hiking swimming or boating on the Premises or of being injured as a result of inclement weather conditions ("Risks"). I agree to release and hold harmless Camp-Resort, its representatives, affiliates, subsidiaries, agents, officers, directors, employees, successors and assigns, from any and all claims, demands, losses, costs, expenses or damages, including without limitation reasonable attorney's fees, which may arise out of or in connection with my undertaking of these Risks. Without limiting the generality of the foregoing, I specifically acknowledge that Camp-Resort is not liable for injuries or property damages resulting from such Risks.

I represent that I am the parent or legal guardian of any minor children that accompany me, and I hereby consent to the foregoing on his/her behalf. If you do not wish to agree to these terms, then you should not enter the Premises.
