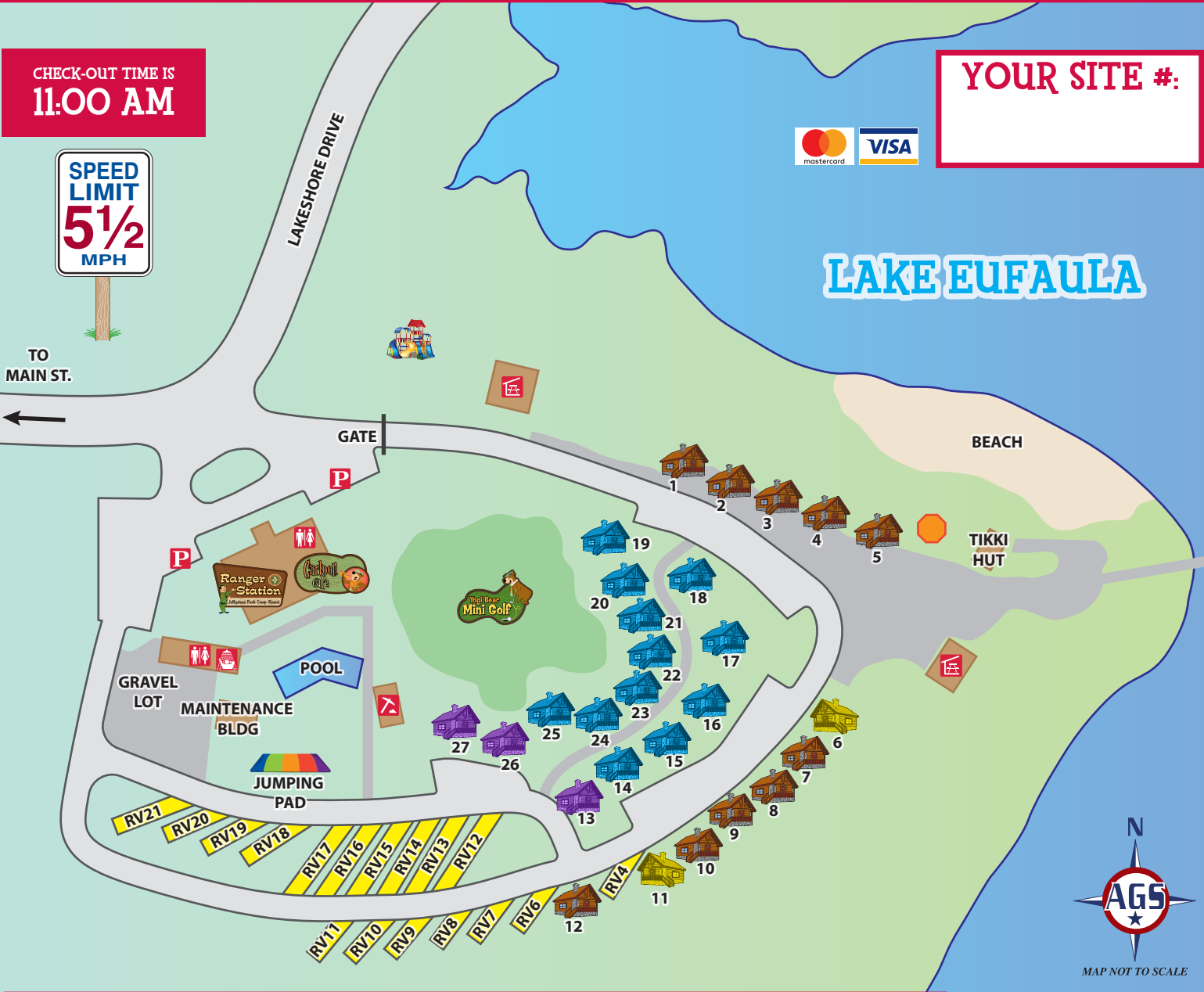

# Welcome to Yogi Bear's Jellystone Park™ At Eufaula



## RULES & REGULATIONS

**CHECK IN TIME:** 4:00 p.m.

**CHECK OUT TIME:** 11:00 a.m.

**QUIET HOURS:** 12:00 a.m. to 8:00 a.m.

**No tent camping permitted in the park.**

**SITES:** One camping unit and one vehicle per camping site. No mats on the ground. No grey water dumped on ground. No vehicle repairs on site. Do not wash your car or RV in the campground. All vehicles must display a Yogi car tag. Maximum of 8 people per site including daily guests.

**CABINS:** At departure, the rental unit is to be left in a reasonably clean condition (broom swept), garbage is to be removed from the rental unit and placed at the curb, all kitchens and kitchenettes are to be left clean, all dishes are to be washed and put away, and the microwave, fridge, stove and countertops are to be wiped clean; otherwise, Jellystone Park™ Management may charge my credit card with a \$75.00 cleaning fee. I understand and agree that if I leave the rental unit in an unreasonably filthy condition, or smoke in a rental unit, Jellystone Park Management may charge my credit card for the cost to professionally clean the rental unit.

All damages to the rental unit, whether caused by myself, my children, guests or pets, will be disclosed to the registration office immediately, or at checkout. All damages occurring to the rental unit during my stay will be charged to my credit card after a thorough inspection has been made by Jellystone Park Management. Damages for which I will be responsible include, but are not limited to: lost key(s), broken/lost TV remote controls, broken items, discharged fire extinguishers (if not used for a fire), damaged/dented/bent appliances, furniture, cabinetry, or dishes, writing on walls or bedding, and ripped or torn mattresses or covers.

**Camping is an outdoor experience and we do not give refunds due to the discomforts of nature. You may experience heat, cold, rain, sunshine, bugs, wildlife, noxious weeds and any number of other adversities. Please be advised that we do everything we can to make your stay with us as pleasant as possible, but sometimes, Mother Nature wins!**

**ROADS:** No ATVs, 3 or 4 wheelers, motorized scooters, or go-carts. Motorcycles are to be used only for transportation in and out of the park.

**BEACH OR OUTDOOR POOL:** Beach and Pool are open from 9:00 a.m. - 9:00 p.m. No lifeguard is on duty at the beach. Swim at your own risk. Glass containers are not allowed inside the pool fence or at the beach area. Please no disposable diapers in the pool; swim diapers must be used. **NO SMOKING ALLOWED IN POOL AREA.**

- Children under sixteen (16) years of age must be accompanied by an adult.
- A cleansing shower bath, using warm water and soap, must be taken before entering the pool.
- Persons with open wounds, bandages, or any symptoms of communicable diseases are prohibited from entering the pool.
- No diving.
- No running.
- No boisterous or rough play.
- "Cut-offs" must be hemmed.
- Excess body lotions must be removed prior to entering the water.
- No persons under the influence of alcohol or drugs allowed in the pool or beach area.
- No animals or pets allowed in the pool or on the deck.
- No persons with skin, eye, ear or nasal infection allowed in the pool.

• Owners and management are not responsible for accidents or injuries.

• Pool is for private use only. Guests must have management permission.

• After using pool, footwear and towels must be used when returning to building.

• Management reserves the right to deny use of pool to anyone at any time.

**RANGER STATION:** Food, drinks, and souvenirs are available. If coming from the pool, please towel dry before entering. Shirt and shoes required.

**MESSAGES:** Will be posted on the message board in the office.

**PETS:** We love pets, and they are always welcome. WITH A \$50 Pet Fee, and a 25 pound limit. Pets must be kept on a leash at all times. Limit 3 dogs per site. Pets are not to be tied outside of your RV when you are not in the park and are not to be left unattended at any time. No ground tie-downs permitted. Pets are not allowed inside any buildings, nor are they allowed on the playground equipment or in the pool area. Excessive barking is not allowed. Aggressive dogs are not welcome. If any pet demonstrates aggressive behavior toward another pet or patron, you will be asked to leave the resort. No pets allowed with day passes.

**VISITORS:** Must register at the office upon arrival. All patrons are responsible for their visitors, and if extra visitors are at your site without having registered, you and your visitors may be asked to leave the resort.

**No Outside ALCOHOLIC BEVERAGES** are allowed in the pool or building areas.

**SMOKING IS NOT ALLOWED IN ANY BUILDING OR POOL AREA.**

**FIREARMS AND FIREWORKS** are strictly prohibited for the safety of all campers.

**CAMPFIRES** are permitted on the ground. Only use self-contained propane unit that is at least 6 inches off the ground.

**TRASH** is picked up daily. Leave at roadside for pick-up. Please do not leave it out after 7:00 p.m.

**BE COURTEOUS AND RESPECTFUL** to your neighbors. Please follow only designated roads or walkways. Please do not cut through occupied RV sites.

**CANCELLATION POLICY:** A credit card deposit equal to the registration charges for your first night is required to guarantee a reservation. The deposit is charged at the time of your reservation. If you are unable to honor your reservation you can call and cancel within 7 days from the reservation. \$100 of your deposit will be used as camp credit.

Without limiting the generality property damages resulting from such Risks. I represent that I am the parent or legal guardian of any minor children that accompany me, and I hereby consent to the foregoing on his/her behalf. If you do not wish to agree to these terms, then you should not enter the Premises.
