

# TUITION ASSURANCE PROGRAM (TAP) 2025

**What if...** Your child is injured, sick, or is unable to attend camp for **ANY** reason?

**Or if...** Your child receives a “once-in-a-lifetime” opportunity for next summer, or simply decides to try something different?

**Or if...** A family emergency or personal financial situation makes it imprudent or impossible for your child to go to camp?

**Or if...** Your child decides he or she is not ready to attend overnight camp this summer?

Camp Lincoln and Camp Lake Hubert are pleased to offer a program that protects your camp investment if you find it necessary to cancel for **ANY** reason prior to the start of your child's camp session. TAP is optional and must be selected and paid for at the time you enroll your child for camp. **The TAP Fee is totally non-refundable.**

## **FREQUENTLY ASKED QUESTIONS**

### **Is TAP the same thing as Trip Cancellation Insurance?**

No. Insurance programs only protect you in the event of specific insured situations (death in the family, loss of job, medical emergency, etc.) and typically have a deductible. With TAP, you can cancel prior to the start of your child's camp session for any reason and 100% of your payments are protected. TAP is more accurately described as a Cancellation Fee Waiver Program, whereby you receive different cancellation options if you sign up for the program. It is more like buying an unrestricted airline ticket as opposed to a non-refundable ticket or one that has penalties attached to changes.

### **Why would I choose TAP?**

With TAP, you can cancel for any reason and 100% of your tuition payments are protected. In addition, if your child needs to leave camp early for any reason, the remaining prorated balance will be retained as a credit that can be used toward that child's tuition for another summer or transferred to his/her immediate sibling.

### **Are my payments really protected if my child cancels without a good reason?**

Yes. You do not need to give a reason to cancel under TAP. The only requirement is that you send us a written cancellation before your child's camp session begins. Depending on when you cancel, a portion of your payments will be retained as a credit for a future camp session for that child or his/her immediate sibling, and the remainder will be refunded.

### **Can I sign up for TAP at any time?**

No. You **MUST** sign up and pay for TAP at the same time you enroll your child. If you do not sign up for TAP and find it necessary to cancel, you will be subject to the standard cancellation penalties outlined during registration.

### **Will I get 100% of my money back if I enroll in TAP and need to cancel?**

Below outlines how your payments are protected if you are enrolled in TAP and need to cancel:

## **TAP REFUND AND CANCELLATION POLICIES**

Prior to January 15 <sup>th</sup>	All Tuition Payments Refunded
January 15 <sup>th</sup> - March 14 <sup>th</sup>	10% of Tuition held as credit, remaining refunded
March 15 <sup>th</sup> - March 31 <sup>st</sup>	20% of Tuition held as credit, remaining refunded
April 1 <sup>st</sup> - May 14 <sup>th</sup>	30% of Tuition held as credit, remaining refunded
May 15 <sup>th</sup> to Start of Session	50% of Tuition held as credit, remaining refunded
