FARES AND FEES:

Delta Air Lines is the preferred airline to Minneapolis because of its nonstop service from many cities. Delta Air Lines assists the camp with luggage collection and the check-in process on all Camp Departure Days. Travel One offers **discounts** on selected **published** fares on United Airlines. Only Travel One can issue these discounted fares. Please note that Travel One issues tickets for all airlines, including Southwest Airlines.

TRAVEL AGENCY FEES / LUGGAGE FEES

When Travel One quotes an airfare, it will include a \$25.00 Travel Agency Fee. If you choose to pay for your ticket via credit card, this \$25.00 Agency Fee may appear as a separate billing item. All major airlines charge luggage fees. This information is located on the airline's website.

UNACCOMPANIED MINOR INFORMATION

The camper's family is responsible for the round-trip unaccompanied minor service fee, if applicable. You must check in at the airline ticket counter to process the unaccompanied minor paperwork. Please allow additional time for the airport check-in procedure (a minimum of 2 hours). A CL/CLH Representative **will be** at the gate in Minneapolis to meet your child. The latest information concerning unaccompanied minor travel will be enclosed with your updated itinerary three weeks before departure.

The Transportation Security Administration (TSA) requires the traveler's full legal name and date of birth when making a reservation.

RESERVATIONS

Travel One has experienced advisors ready to assist you with your reservation. Our team is knowledgeable about CL/CLH and its travel requirements. DELTA AIR LINES UNACCOMPANIED MINOR

CAMPERS AGES 14 YEARS AND UNDER MUST TRAVEL AS UNACCOMPANIED MINORS

OR

BE ACCOMPANIED BY ANOTHER TRAVELER 18 YEARS OF AGE OR OLDER

Airlines have instituted strict regulations regarding security and unaccompanied minors. Delta Air Lines requires passengers ages 14 and under to be accompanied by another individual 18 years of age or older **or** purchase unaccompanied minor services from that airline.

IMPORTANT: Delta will allow up to four children, both family and non-family members, to travel under the cost of one unaccompanied minor service, but only one parent/adult will be allowed to accompany all the children to the gate. **The children must check in together both at the airport check-in counter and at the gate. Travelers must all be listed on the same unaccompanied minor form. Campers must travel together in both directions.**

On the return flight, the adult or adults indicating responsibility for all the children on the unaccompanied minor form **must be present at the airport to pick up the minors.** If the specified adult is not present at the airport, Delta or other airlines will not release the children.

The family should purchase this service on a **round-trip basis** unless the camper is only traveling one way. The cost is \$150.00 one way or \$300.00 round trip for both nonstop and connecting flights.

Delta is using a barcoded wristband that will be scanned at important points of the unaccompanied minor's journey. Scan events allow Delta to have added visibility to the minor's location while traveling.

NOTE: When checking in an unaccompanied minor, you will need the following information so that a camp representative can meet your child at the gate.
