## he Mission & Vision of Visitation House Ministries



#### Our Mission

VHM enables mothers and their children to live in safety and security and provides supportive services to those who are experiencing homelessness or at risk.

#### Our Vision

The majority of homeless families are headed by young, single women with children. Life is difficult for these families. We aim to educate and empower these women and children by providing safe, stable housing and access to educational resources.



#### **VISITATION HOUSE MINISTRIES**

#### History and Mission

Incarnate Word Sisters, Neomi Hayes and Yolanda Tarango, founded Visitation House Ministries (VHM) in 1985, based on the mission to respond to the needs and concerns of economically vulnerable women and children. VHM began as a short-term emergency shelter but in order to offer an alternative to the revolving door aspect of shelter life, the Sisters transformed services in 1993 into a two-year Transitional Housing and Outreach Education Program.

VHM has always been attentive to the importance of education as a strong shield against poverty. Through its focus on education, the program successfully transitions women out of homelessness, prevents recurrent homelessness and ensures community re-integration of the family.



Visitation House

#### Transitional Housing and Outreach Education Program

Core services include: 1) Transitional Housing. 2) Social Services. 3) Education Programs.



La Posada Transitional Apartment Building

The service enriched housing program provides direct services to each family, including case management, parenting, counseling, mentoring, educational assistance, budgeting and independent living skills training. We seek to create an atmosphere of common caring and mutual respect and are committed to ensuring an environment where mothers and their children can develop self-confidence, excel academically and also feel safe and secure, living in stable and healthy surroundings. Women who are college-ready attend one of the local community colleges in pursuit of either a one-year Certificate or a two-year Associate Degree in a chosen field. Women who are not yet prepared to enter a college program usually study GED and/or English as a Second Language (ESL). Children's program services are also provided through an afterschool enrichment program, child-specific learning, and play zones.

#### **Outreach Education Program**

VHM extended the valuable education services into the community in 2006 with the launching of the Outreach Education Program to serve a broader population of economically vulnerable women than the housing program could provide. The goal of outreach education is to increase independence for these women by earning a GED, and/or learning English, and thus give them the tools and the confidence to take the next step in their education advancement or employment or to be able to help their children with school work. Whatever their personal goals may be, their participation in the program will ultimately empower them to provide a better quality of life for their families.
