Thank you for supporting our Islanders as they pursue their academic goals and work to extend their impact beyond the Island as our next generation of community leaders and innovators. Your generosity enables our university to create a culture of excellence and innovation among our faculty, staff, and students. We are extremely grateful for your commitment to the Island University and are pleased to report on the performance of your endowment for the fiscal year ending August 31, 2024.

During the 2023-2024 academic year, we awarded over \$1.5 million in endowed scholarships and conferred 2,757 degrees, 45% of which were awarded to first generation college students. The Texas A&M System Endowment Fund recorded \$1.6 billion in assets at the end of the 2024 fiscal year. This results in a one-year return of 12.9%, as well as three, five and ten-year annualized returns of 1.7%, 6.9% and 6.3%, respectively. Texas A&M University-Corpus Christi's portion of the endowment is valued at \$23,956,472.86 as of August 31, 2024.
