TO ENSURE THE COMFORT AND SATISFACTION OF OUR GUESTS, YOUR PET'S STAY IS SUBJECT TO THE FOLLOWING RULES:

1. All guests with pets must complete and sign the pet admission form and pay a fee of EUR 15 per night per pet, except for guide dogs which can stay free of charge. A cash deposit of €100 per pet is required during check-in as a guarantee against damages.
2. Pet food, bedding and pet pillows are not included in the daily rate. The NAU Salema Beach Village offers an animal kit with surprises for your pet.
3. Pet owners must comply with international and Portuguese law or any other law or regulation, including pet licensing.
4. No pets other than cats and dogs will be accepted. The breeds of pets must be informed to the hotel in advance, subject to acceptance by the hotel.
5. The Hotel reserves the right to request the immediate removal of any animal exhibiting dangerous or unacceptable behaviour such as biting, scratching, excessive barking, evidence of illness, or urination or defecation in public areas. The guest's Villa may not be occupied by more than two pets, under penalty of being removed from the property and the pet owner being liable for any and all resulting consequences and expenses.
6. Except for guide dogs, animals are not allowed in public areas such as: spa, gym, swimming pools, bars, restaurants and terraces. Whenever they are in any public area of the Hotel, all animals, with the exception of guide dogs, must wear a leash or be carried by their keepers.
7. For the safety and comfort of the pet, housekeeping and/or maintenance teams will only enter the room if the pet is either not present or properly restrained with a leash or other type of device. We request that the signs available for this purpose be placed outside the door of the room whenever your pet is in the room. The hotel does not accept any responsibility whatsoever in the event your pet escapes or disappears.
8. The pet owner agrees to release, defend and indemnify NAU Salema Beach Village from any and all claims or losses relating to their pet or their pet's stay at the Hotel, including any third-party claims.
9. Upon check-in, the hotel will request a valid credit card for the payment of any damages or extraordinary cleaning relating to the pet's stay. By signing this agreement, the pet keeper is formally authorising the Hotel to charge these costs to their credit card during or after their stay. At check-in it is compulsory to present an up-to-date vaccination bulletin and life insurance for the animal, covering accidents or damage to third parties.

I have read, understood and received a copy of the Regulations for the admission of animals at NAU Salema Beach Village and I promise to comply with them fully and to accept responsibility for any damage or injury caused by my pet.
